

**WORKSHOP MINUTES  
SEMINOLE CITY COUNCIL  
March 27, 2018**

The Workshop of the Seminole City Council was held on Tuesday, March 27, 2018, in City Hall, City Council Chambers, 9199 - 113th Street North, Seminole, Florida.

Mayor Waters called the workshop to order at 7:17 p.m.

Present were: Mayor Leslie Waters, Vice Mayor Roger Edelman, Councilor Thomas Barnhorn, Councilor Chris Burke, Councilor Bob Matthews, Councilor James Quinn, Councilor Trish Springer, Community Development Director Mart Ely, City Attorney Jay Daigneault, and City Clerk Patty Beliveau. City Manager Ann Toney-Deal was absent.

**1. INTERVIEW LIBRARY ADVISORY BOARD MEMBER APPLICANT**

Mayor Waters recognized Trish Haynes to speak at the podium. Mrs. Haynes explained her background, her involvement in the community and her interest to serve on the Library Advisory Board. Library Director Bryan stated that Mrs. Haynes will be an asset to the Library Advisory Board.

Mayor Waters noted that Council will vote on Mrs. Haynes appointment to the Library Advisory Board at the April 10, 2018, council meeting.

**2. DISCUSS ORDINANCE NO. 07-2018:**

**AN ORDINANCE OF THE CITY OF SEMINOLE, FLORIDA, AMENDING CHAPTER 20 – MISCELLANEOUS PROVISIONS, OF THE CODE OF ORDINANCES OF THE CITY OF SEMINOLE, FLORIDA, REGULATING DESIGNER DRUGS; CREATING SECTION 20-2 OF THE CODE TO PROHIBIT THE SALE, GIVING AWAY, OFFER OR ADVERTISEMENT FOR SALE, OR PUBLIC DISPLAY FOR SALE, OF SYNTHETIC CANNABINOID HERBAL INCENSE, CONTRABAND BATH SALTS, KAVA, AND KRATOM THAT MIMIC ILLEGAL DRUGS; PROVIDING DEFINITIONS; PROVIDING FOR SEIZURE AND INJUNCTIVE RELIEF; PROVIDING FOR PENALTIES; PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE;**

Mayor Waters stated since the first reading of Ordinance No. 07-2018, Council has received emails, and telephone calls regarding Kava and Katrom. Attorney Daigneault explained that since the first reading of Ordinance No 07-2018, there has been no changes to the legality of the Ordinance as presented during the March 13, 2018, council meeting. It is a Council decision as to what action to take on the Ordinance.

Council discussed the workshop process; their research of Kava and Katrom since the Ordinance's first reading, and noted that the Ordinance does not ban the consumption or possession of Kava or Katrom in the city.

Council consensus was to not move forward with a second and final reading of Ordinance No. 07-2018.


**3. CONSIDER A MOTION FOR ADJOURNMENT:**
