3. ACTION ITEMS

A. CONSIDER FIRST READING OF ORDINANCE NO. 13-2018 AUTHORIZING A BUDGET AMENDMENT TO INCREASE LEGISLATIVE, ADMINISTRATION, COMMUNITY DEVELOPMENT AND PUBLIC WORKS ACCOUNTS BY \$1,519,023 TO REALLOCATE FUNDS FROM THE FISCAL YEAR 2016-2017 END OF YEAR FUND BALANCE.

City Clerk Beliveau read Ordinance No. 13-2018 by title only. City Manager Toney-Deal explained that each year, City Council reviews and approves an ordinance reallocating surplus funds from the prior year. The funds for Waterfront Park were previously approved by Council and have been incorporated into the Ordinance.

Motion made by Councilor Quinn, seconded by Council Barnhorn to approve Ordinance No. 13-2018 on first reading.

City Manager Toney-Deal and Administration Director Kyne explained the allocated funds for each line item. City Manager Toney-Deal further noted that CIP items will be brought before Council for final approval prior to purchasing.

B. APPROVE RESOLUTION NO. 06-2018 ESTABLISHING THE 2018 GOALS FOR THE CITY OF SEMINOLE.

City Clerk Beliveau read Resolution No. 06-2018 by title only. City Manager Toney-Deal explained that the 2018 Goals were identified by Council during the Annual Workshop. The 2018 Goals will be combined with other on-going Goals previously established by Council. Council may add or delete throughout the year, if they so desire.

Motion made by Councilor Springer, seconded by Vice Mayor Edelman to approve Resolution No. 06-2018, establishing the 2018 goals for the City of Seminole.

ALL IN FAVOR. MOTION PASSED UNAMINOUSLY

C. CONSIDER AUTHORIZING THE CITY MANAGER TO ACCEPT A BID FROM MORELLI LANDSCAPING, INC. FOR THE BAY PINES BOULEVARD LANDSCAPE REHABILITATION PROJECT.

City Manager Toney-Deal explained that the City was awarded a \$75,000 Grant from the Florida Department of Transportation for landscaping. The project limits are from Long Bayou Bridge to State Route 666 and the Seminole Boulevard overpass. Council approved to upgrade the landscaping on Bay Pines Boulevard corridor, which will include six Medjool Date Palms.

Motion made by Councilor Quinn, seconded by Councilor Burke to authorize the City Manager to accept the bid from Morelli Landscaping Inc. for the Bay Pines Boulevard Landscaping Rehabilitation Project and enter into an agreement/contract for said services.

D. AUTHORIZE THE CITY MANAGER TO EXECUTE THE STATEWIDE MUTUAL AID AGREEMENT WITH THE STATE OF FLORIDA, DIVISION OF EMERGENCY MANAGEMENT FOR A PERIOD OF ONE YEAR WITH AUTOMATIC RENEWAL EACH YEAR FORWARD UNLESS SPECIFIED.

City Manager Toney-Deal explained the Statewide Mutual Aid Agreement includes provisions for the agreement to be used for smaller disaster management events in addition to larger events such as Hurricane Irma. The agreement will be in force for one year and will automatically renew each year unless the City notifies the Division of Emergency Management within 60 calendar days of its intent not to renew.

Motion made by Councilor Burke, seconded by Councilor Barnhorn to authorize the City Manager to execute the Statewide Mutual Aid Agreement with the State of Florida, Division of Emergency Management.
