

ORDINANCE NO. 14-2013

AN ORDINANCE OF THE CITY OF SEMINOLE, PINELLAS COUNTY, FLORIDA; AMENDING THE BUDGET TO RECOGNIZE ADDITIONAL REVENUE OF \$295,100 FROM THE CITY RESERVES FOR CAPITAL PROJECTS AND TO PROVIDE AN ADDITIONAL BUDGET APPROPRIATION IN THE AMOUNT OF \$295,100 FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2013 AND ENDING SEPTEMBER 30, 2014; PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, estimated revenues and expenditures are provided in Ordinance No. 09-2013, Budget Ordinance; and

**WHEREAS**, the authority for appropriation amendments is provided in Article IX, Section 9.02 of the City Charter; and

**WHEREAS**, it is the desire of the City of Seminole, Pinellas County, Florida to transfer \$295,100 from the Unreserved Designated for Capital Projects and to appropriate \$295,100 to the listed accounts for City Wide Capital Projects and equipment.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SEMINOLE, PINELLAS COUNTY, FLORIDA, DOES HEREBY ORDAIN:**

SECTION ONE. Transfer \$295,100 from account 01-0389-9015 Unreserved Designated for Capital Projects.

SECTION TWO. The sum of \$295,100 is appropriated to the following accounts.
