B. AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT WITH PLAYMORE RECREATIONAL PRODUCTS AND SERVICES IN AN AMOUNT NOT TO EXCEED \$750,000 FOR THE CONSTRUCTION OF AN ALL ABILITIES PLAYGROUND AT WATERFRONT PARK.

City Manager Toney-Deal stated that the City received a \$250,000 grant for this project which required a \$250,000 match, and there is also an additional \$250,000 in the budget. Reference checks were completed, and Playmore Recreational Products and Services was chosen after receiving outstanding references. Staff is recommending that a contract for the playground be awarded to Playmore Recreational Products and Services.

Motion made by Councilor Barnhorn, seconded by Councilor Quinn to authorize the City Manager to enter into a contract with Playmore Recreational Products and Services in an amount not to exceed \$750,000 for the construction of an all abilities playground at Waterfront Park.
