#### **5. CITY MANAGER REPORT**

##### **A. COMMUNITY POLICING REPORT.**

Community Policing Officer, Deputy Siem stated that he attended the Taco Fest at Seminole City Park. He also gave accolades to the Seminole Recreation Department for its events being so organized, he stated that it makes the Deputy’s job so much easier;



he stated that since the last Council meeting there was an inquiry about the speeding on 113<sup>th</sup> Street North, and since then a speed stealth was deployed, and a report will be forthcoming. He gave a reminder that school will soon be out for the summer, to be mindful of the children, and lastly, he stated that he will be in attendance at the Annual Kids Appreciation Day at Seminole City Park on May 26, 2022, and the Food Truck Rally in June.

#### **B. INTRODUCTION OF NEW COMMUNITY DEVELOPMENT DIRECTOR.**

City Manager Toney-Deal introduced Community Development Designee Wesley Wright. Wesley will officially be the Community Development Director on June 17, 2022.

City Manager Toney-Deal asked the St. Petersburg College Collaborative Lab to give all available dates from July 25, 2022, through September 30, 2022, for the Strategic Planning Session. It will take place at the Seminole Campus of the College.

City Manager Toney-Deal also announced that the Florida League of Cities Annual Conference is now open for registration and that in celebration of the Florida League of Cities 100<sup>th</sup> Birthday, the first 100 elected officials who are first time attendees will receive a free registration.

City Manager Toney-Deal also stated that when she receives the report from the Pinellas County Sheriff's Office in reference to the speed stealth on 113<sup>th</sup> Street, she will share those results with Council.

Councilor Christy inquired about the property at 9575 Seminole Boulevard and whether it could be used for a ballpark. City Manager Toney-Deal stated that the property is owned by the Pinellas County Housing Authority, and there are current plans for development of the property.

Councilor Edelman inquired about the Frontier Cable installation and what the completion date is. City Manager Toney-Deal will follow up and send an email to Council.

Councilor Springer inquired as to whether electric wheelchairs can utilize the bike lanes on the roads. Councilor Burke stated that it is indeed legal.

Mayor Waters inquired as to what date the representative from Pinellas County will be attending a Council meeting in reference to the traffic signalization. City Manager Toney-Deal stated that he will be in attendance at the July 12, 2022, workshop meeting.
